In Memoriam: Mr. Whit Palmer

Whitfield McRory Palmer, Jr., 90, of Ocala passed away on Wednesday, January 1, 2020 at home. Whit was a long-time supporter of Phoenix House Florida. In the early 1990's, Whit, along with his friend Fred Fisher, wanted to help their sons who were struggling with the consequences of substance use related issues. Through a friend, they found help for their children in a Daytop rehabilitation program in New York. The experience with their children created a desire to assist Daytop in establishing a similar program in Florida. Whit's daughter, Susie, found a former hospital facility in Citra, Florida and the facility opened in 1994.



After a few years, and the realization that additional support was needed to expand Daytop Florida, Fred and Whit contacted Phoenix House Foundation. In 1998, the two organizations entered into an affiliation agreement resulting in the current day Phoenix Programs of Florida (Phoenix House Florida).

Whit began his career in the mining industry with Dixie Lime and Stone Co., and became president and CEO. He later purchased MFM Industries. As president of Paddock Park Development, Whit was a real estate developer in Marion County. He also served as president and chairman of HydroMentia, Inc., an aquatic plant-based water treatment company for large scale environmental restoration.

A longtime member of the Florida Council of 100, Palmer also served on the boards of Florida TaxWatch, the Florida Chamber of Commerce, UF Health Shands Hospital in Gainesville and Munroe Regional Healthcare System in Ocala. Whit Palmer was the consummate maker of connections and when actor Paul Newman decided to build a Hole in the Wall Gang Camp in Florida for children with serious and life-threatening diseases, he recruited Whit to lead the successful effort to build and establish what is now Camp Boggy Creek.

"He was born here and grew up here and had a strong affection for our town and Marion County," Margaret Palmer Parks, one of his daughters, said in a telephone interview. "And (he) was always trying to find ways to add to it, to enhance it, whether it was education or commercial opportunities" or other areas. He had "a huge affinity for the hospital and was very proud of the level of health care the community had," Parks said.
